Dear Torres Strait Fish Receiver Licence Holder,

Notification of variation of licence conditions to enable a black teatfish trial opening.

I am writing to inform you that I, as a delegate of the Protected Zone Joint Authority (PZJA), under section 22 of the *Torres Strait Fisheries Act 1984* have varied the conditions of your fish receiver licence for the Torres Strait Beche-de-mer Fishery to enable a trial opening of fishing for black teatfish to commence on 30 April 2021.

On 27 August 2020, the PZJA agreed to a trial reopening of the fishery for black teatfish subject to a 20 tonne Total Allowable Catch (TAC) and requirement of daily landing and daily reporting of catch through the mandatory fish receiver system. Since that time AFMA has consulted stakeholders on the preferred timing for the opening. Having considered advice received, AFMA has set the commencement date for the opening to be 30 April 2021 and ending on the **TAC Date**. The **TAC Date** is the day that the PZJA or its delegate determines based on its reasonable belief that the TAC will be reached.

The new conditions that will apply to your licence are enclosed and are as follows:

From 30 April 2021 you must electronically send an image of the white original copy of the completed TDB02 Catch Disposal Record (CDR) pages within the same day of receiving catches of black teatfish. You can send the image using a smart phone or other electronic devices, as a photograph via

You are still required to return to AFMA a hard copy of the white original copy of the completed CDR page within three (3) days of receiving the catch.

From 30 April 2021 until a Total Allowable Catch Date (TAC Date) for black teatfish is determined by the PZJA or its delegate, you must send AFMA electronically to email: blackteatfish2021@afma.gov.au or SMS: 0437 825 291 or Fax: 07 4069 1277, an image of the white original copy of the completed TDB02 Catch Disposal Record pages within the same day of receiving catches of black teatfish.
