PLAN	<ul> <li>Ahead and make sure you have:</li> <li>enough pages left in your Catch Disposal Record (CDR) book</li> <li>the ability to email, SMS or fax an image/photo of your completed CDR to AFMA from your fish receiver premises</li> <li>mobile phone reception and internet connection</li> </ul>	
NOMINATE	If required, an authorised agent to sign the fish receiver section of the CDR. The same person cannot sign the fisher details section and the fish receiver section of the CDR

# AFTER TAC DATE# DO NOT RECEIVE BLACK TEATFISH

<sup>&</sup>lt;sup>#</sup> The **TAC Date** is the specific date and time that the PZJA or its delegate determines as the last day of fishing for black teatfish based on its reasonable belief that the TAC will be reached, in order to avoid an overcatch of the TAC. If the last day of fishing for black teatfish is not a full day, the PZJA or its delegate may provide additional time to receive black teatfish after the TAC Date.

## Black teatfish opening Rules for fish receivers



#### Fish receivers MUST

- ✓ Hold a current fish receiver licence
- ✓ Ensure the receiver premises on the licence are up-to-date
- ✓ Only receive catches from licenced fishers
- ✓ Only receive catch at premises nominated on your fish receiver licence
- Send an image/photo of your completed CDRs electronically to AFMA on the same day you receive the catch. This means daily

#### Fish receivers MUST NOT

- Receive black teatfish **before** 29 April 2024
- Receive black teatfish after the TAC Date#
