Fishery entry on any type of fishing boat licence on a boat 15m or longer	\$80/entry
Grant or renew a processor-carrier boat licence (Class A)	\$20
Grant or renew a carrier boat licence (Class B)	\$80
Grant or renew a processor-carrier boat licence (Class C)	\$100
Transfer or temporary transfer of a licence	\$10/licence
